Additional Information

ENTRY INFORMATION: Entries for Championship, Premiership, AOV, and Provisional classes must have the registration number on the entry blank and printed in the catalog. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Entry clerk will phone collect to clarify entries where necessary. BENCHING requests will be honored wherever possible. Only one benching or Agent request per exhibitor, please. NO NEGATIVE REQUESTS. CFA Show Rules will be strictly enforced. A copy of the Show Rules may be obtained from CFA by sending \$7.00 to 260 E. Main St., Alliance, OH 44601 or by accessing the CFA website at <http://www.cfa.org/pubs.html#showrules>.

MAKE CHECKS PAYABLE TO: Tonks West. Early Bird entries must be paid in full by 9/26/2011. No refund for failure to bench. No postdated checks. \$50 charge for returned checks. No kittens under the age of 4 months are allowed in the show hall. FEES must accompany a signed Entry Blank, unless Faxed or E-Mailed. Per CFA Show Rules, ALL FAX or E-MAIL ENTRIES must be paid within 10 days or at check-in, whichever comes first.

SHOW HALL: The Visalia Convention Center, 303 E Acequia Avenue, Visalia, CA 93291-6341, 559-713-4000. We are in the San Joaquin and Charter Oak Ballrooms. Free parking is available behind the Convention Center or on the upper floors of the Parking Garage across the street at the Comfort Suites Hotel. The show hall is air conditioned, heated, and handicapped accessible. SMOKING IS NOT PERMITTED. If you have small children, please keep them under control.

DIRECTIONS to Show Hall: From CA 99 (north or southbound), take exit 96 to merge onto CA-198 E toward Visalia. Take exit 107A to merge onto CA-53/W Noble Ave toward Visalia/Central. Turn left at CA-63/S Court St. Turn right at E Acequia Ave. The Convention Center will be on the right.

DIRECTIONS to Lamp Liter Inn: Take Highway 99 North or South to Highway 198 East. Take Demaree Street Exit. Go straight through Demaree intersection to County Center Road. Go Left.

Show Hotel: A block of rooms is available for exhibitors at the Lamp Liter Inn, 3300 W. Mineral King, Visalia, CA 93291. (800) 662-6692, at the group rate of \$69 per night plus tax. Cats are accepted and the \$20 pet fee is waived if they are caged while in the rooms. To take advantage of this rate, ask for the "cat show" rate and make your reservations no later than October 14, 2011.

CHECK IN: Check-in time will be from 7:30 – 8:30 a.m.. Judging will begin promptly at 9:00 a.m. Advertised Show Hours are 9:00 a.m. to 5:00 p.m. No cage may be dismantled without the Show Manager's approval until all finals have been completed.

BENCHING: Single cages are 21" x 21" x 21". Double cages are 21" x 21" x 45". Only one cat or two kittens per single cage per CFA Show Rules. If your security cage is wider than 21" you will need to request and purchase additional space(s) with your entry.

LITTER: Will be provided. Bring your own litter pans, cat food and dishes.

FOOD: There is no on-site food available, but there are several fast food, etc., places located nearby. You may bring your own food. Grand parties are welcome.

HEALTH: This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, and calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fleas, ear mites, and fungus and must show no signs of illness. All claws must be clipped prior to benching. Declawed cats are not allowed for entry, per CFA Show Rules.

HOUSEHOLD PETS: CFA Southwest Region has given permission to score region 5 HHPs at this show! Household Pets must be 4 months of age or older on the opening day of the show, and if 8 months of age or older must be spayed or neutered. All nails must be clipped and cats should be bathed. Declawed cats are not eligible for entry. Contact the Show Manager if this is your first show or if you have any questions.

AWARDS: All championship, premiership and registered kittens (whose registration number is printed or written in ink in the catalog) will be scored for Regional & National awards per CFA Show Rules. Ribbons and awards will be given according to CFA show rules. Permanent awards will be used for class awards. Fabric ribbons will be available on request.

NEW EXHIBITOR: Tonks West welcomes you. If you have questions regarding your entry, please feel free to call a Show Manager listed on the front. Please identify yourself at check-in and we'll try to help make this a pleasurable first showing for you and your cat.
